# BICYCLE SAFETY POLICY & GUIDELINES

*Updated 2015*

Students may wish to ride a bicycle or foot scooter to school when they are 10 years or older. This policy states the eligibility of students for riding to school, recommendations from the RMS (formerly RTA) and the Department of Education and Communities, Responsibilities and Expectations of the School, Parents and Students.

## Who is eligible?

After the signed permission note has been returned to school and the student has been issued with a 'St Finbar's School Rider Licence' then any student 10 years or older is eligible to ride a bicycle to school. The 'St Finbar's School Rider Licence' will only be valid for the school year that it is issued. A new permission note will need to be signed each year before a licence is issued. A requirement to ride to school is that all students must have a well maintained bicycle with operating brakes and a bell. All students that ride to school must wear a helmet that complies to the Australian Standards.

## What does the Department of Education and the RTA say?

The Department of Education and NSW Centre for Road Safety (RMS) recommend that children under 10 years of age should cycle in a **safe place off the road and away from vehicles and driveways**. Children aged between 10 and 12 years of age should avoid cycling on or near busy roads.

## The School is responsible for:

- ensuring that all students that ride to school have returned a signed permission note from their parents
- ensuring the safety of the bike rider and other students in the playground by having set rules for bike riders entering the school grounds
- issuing students with a 'St Finbar's School Rider Licence'
- providing an area where students can lock their bicycle up safely
- deciding if a student can or cannot ride to school due to infractions of the outlined rules for riding to school.

## Parents and carers are responsible for:

- the maintenance of their child's bicycle and are to ensure their child always correctly wears an Australian Standards approved helmet when riding. Bicycles must be in a good, safe working order and must be fitted with a working brake and a bell
- ensuring their child is aware of and follows the road rules relating to bicycles. This includes the pedestrian's right of way on footpaths and using a bell as a warning when approaching pedestrians
- reinforcing rules and safety advice for riding bicycles to and from school, as outlined in these guidelines and RMS advice brochures.

## Bicycle riders who bring their bicycle onto school grounds are responsible for:

- completing a 'Bicycle Rider's Agreement' and the 'Bicycle Rider's Permission Note' issued by the school. This is to be completed and returned to the Assistant Principal
- ensuring that they walk their bicycle through the playground
- storing their bicycle in the bicycle rack behind the infants toilet block. Bicycles must be locked with a chain and padlock supplied by the bicycle owner. **Bicycles and helmets are brought and stored at school at the owner's risk**

**Safe riding behaviours:**

- Students are to always correctly wear an Australian Standards approved helmet when riding
- Students must always ride in a safe manner following these guidelines and the NSW road rules relating to bicycles
- Bicycles are not permitted to be ridden on school grounds unless supervised by a teacher for practical bicycle lessons
- Bicycles are not to be ridden in school grounds after school hours
- Bicycles must be walked in and out of the school
- Parents and carers will be notified if their child does not adhere to the school's bicycle safety guidelines. Students may not be allowed to bring their bicycles onto the school grounds if they do not follow the rules
- In the event that the child does not follow the School's Bicycles Safety Guidelines then the Principal or Assistant Principal can confiscate the licence for a period of time that seems fit.
